The undersigned, individually, and Guest also hereby release, waive, discharge, and covenant not to sue the Released Parties, or any employee, owner, or representative thereof, for any property damage, personal injury, other damages, or other liability which arises out of or relates to the Event and/or the Artwork exhibit. The undersigned, individually, and Guest hereby assume full responsibility for any risk of bodily injury and/or property damage which arises out of or relates to the Event and/or the Artwork exhibit, whether or not caused by the negligence of any Released Party. The undersigned, individually, and Guest further agree to indemnify and hold harmless the Released Parties, and their employees, owners, and representatives, from any and all losses, liabilities, damages, and costs they may incur which arise out of or relate to the Event and/or the Artwork exhibit.
